Dear Parents and Carers

Each year, Oakleigh State School requests direct financial support in the form of a voluntary contribution scheme. In previous years, this scheme has raised up to \$50 000 of additional funds to support and enhance the learning programs for all students.

This year, we are requesting a contribution of \$80 if you have one child at Oakleigh, \$140 if you have two children enrolled, and \$190 if you have three or more students currently enrolled.

This year, we have identified two ways in which these funds will be used to support all students:

1. 75% of these funds will be used to ensure quality ICT (Information and Communication Technologies) and Digital Technologies are in place at our school to support student learning
2. 25% will go towards all classes and students engaging with our Sustainability officer, through a unit of work that contains a strong element of Sustainability.

Further details regarding the planned expenditure of this contribution will be in this week's newsletter.

The 2018 Voluntary Contribution has the full support of the P&C Association and was endorsed at the February meeting. The scheme meets all applicable Education Queensland policy guidelines. The contribution is not a fee, and will not be invoiced.

I would strongly encourage all parents to participate in the Voluntary Scheme.

I understand that this financial commitment may be difficult for some families and encourage you to discuss any questions you may have about the scheme with myself or Belinda Riley, our Business Manager.
